ARTICLES OF INCORPORATION

OF THE

"GREENKRAFT CORPORATION"

Name of Corporation

Known All Men By These Presents:

The undersigned incorporators, all of legal age and majority of whom are residents of the Philippines, have this day voluntarily agreed to form a stock corporation under the laws of the Republic of the Philippines.

THAT WE HEREBY CERTIFY:

FIRST: That the name of this corporation shall be:

GREENKRAFT CORPORATION

SECOND: A. That the primary purpose of this corporation is:

To engage in the business of trading goods such as per craft roll and other related products or items on wholesale/retail basis.

B. That the secondary purpose of this corporation is:

To engage in, operate, conduct and maintain business of assembly and conversion of corrugated cartons into boxes or packages, importing, exporting, buying and selling or otherwise dealing in wholesale or retail of goods as corrugated cartons, paper products and other similar in nature and any and all equipment, material supplies used or employed in or related to the manufacturing of such finished products and to buy and sell, deal in wholesale or retail of scrap papers and other similar in nature and other recyclable materials.

- C. That the corporation shall have all the express powers of the corporation as provided for under Section 36 of the Corporation Code of the Philippines.
- THIRD: That the place where the principal office of the corporation is to be established at W. Ng Bldg. Mac Arthur Highway Cor. Rovimar St., Balibago, Angeles City. (As per meeting last March 10, 2014).
- FOURTH: That the term for which the corporation is to exist is fifty (50) years from and after the date of issuance of the certificate of Incorporation.

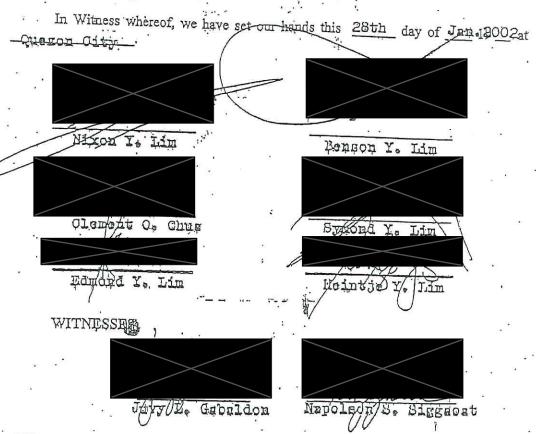
